# Conclusions

### Point 1

### Conclusion 1

The Executive Board of the Association approved the minutes of the  $3^{rd}$  meeting of the Executive Board of the Association, held on December  $11^{th}$ , 2018 in Celje.The Board took note of the minutes of the  $2^{rd}$  correspondence meeting of the Assembly of the Association, held from May  $29^{th}$  to June  $1^{st}$  2019.

The Board took note and approved the Report of the association in 2019. Uroš Pintar suggested that the program of the international association primarily involves international projects. Depending on the content of the projects, members of the Association of Sports Centers may also be invited to participate.

The Association's 2019 activity report includes the following projects:

#### Conclusion 3

The Executive Board took note and approved of the association's 2020 program. The program includes:

- Project: RE-PLAN CITY LIFE. Audience Plan Leading to Awareness Network for Circular Economy
  Use of Recycled Tire. The European Commission EU LIFE Program 2018. Circular Economy.
  Cooperation with partners: ETRA France, ANCI Lazio Italy, ANTEL Italy, District of Turin Italy,
  Government of Catalonia, Spain, COSMA Spain, IteC Spain, Crete Regional Authority Greece,
  Keridis Greece, Turin Italy Polytechnic and EuRIC Belgium.
- <u>International Sport Business Symposium</u>. Environmental Sustainability. Collaboration with Universities: University of Mainz and Tsukuba University Tokyo.
- Project: Sport and Leisure Infrastructure Management Standards, covering the following areas:
  - (1) Preparation of updated management standards.
  - (2) Collection of practical examples in collaboration with members and partners.
  - (3) Drafting of the manual in electronic form.
  - (4) Organization of training programs.
  - (5) Preparation of an international conference. Collaboration with professors, experts, managers and others who have participated in the preparation and implementation of international projects, conferences and seminars conducted by the Association in recent years.
- Preparation and convening of the fourth 4<sup>th</sup> meeting of the General Assembly and meetings of the Executive Board.
- <u>Marketing activities</u>. The founding members will provide advertisers for advertising on the association's website and publications.
- <u>Administrative operations</u> of the association. The operation of the office of the association. Editing the association's website. Business correspondence. Accounting business.

- Other activities of the Association, which will be approved by the Board and included in the annual program of the Association.
- The Secretary will look into the possibilities for organizing a <u>professional excursion</u> that will include outdoor areas for sports and leisure.
- <u>Financial plan</u>. The Board will prepare a proposal for a plan for the spring meeting of the Association Assembly. The planned revenue will be generated from the following sources:
  - (1) marketing activities,
  - (2) European Commission funding for participation in international projects, and
  - (3) other sources of funding.

The planned outflows (costs) will include:

- (1) financing the association's operating costs,
- (2) covering the costs of participation in the international projects,
- (3) other operating expenses, and
- (4) VAT charged to the association as an atypical VAT payer due to inflows or payments of bills from abroad. The budget will be the similar as in 2019.
